Data

What data do we collect

Our company collects the following data

Data you give us

- Personal identification information such as name, email address, phone number, details of the device you use, etc.
- Records of our discussions, if you contact us or we contact you

Data created during use of our website

- Usage data: We collect data about how users interact with our website. This includes data such as access dates and times, website forms, linked clicked and pages viewed, length of visit, app crashes and other system activity, and type of browser. We may also collect data regarding the third-party sites or services used before interacting with our services, which we use for marketing. In some cases, we collect this data through cookies, pixels, tags, and similar tracking technologies that create and maintain unique identifiers. To learn more about these technologies, please see our cookies notice below
- Device data: We may collect data about the devices used to access our services, including the hardware models, device IP address or other unique device identifiers, operating systems and versions, software, preferred languages, advertising identifiers, device motion data, and mobile network data.

How do we collect your data

You directly provide invesTRe with the data we collect. We collect data and process data when you:

- voluntarily subscribe for news and updates on our website: www.investre.eu
- use or view our website via your browser's cookies
- interact with our advertising on third party websites

How we will use your data

Our company collects your data so that we can:

- send you emails with updates about our project, products and services;
- for marketing purposes such as providing you with information about products and services we offer (where allowed by law), including using information about you to better understand you interested. You can opt out of this by unsubscribing to our emails. We also use data to measure and understand the effectiveness of our marketing activities.

How do we store your data

Our company's website is hosted on the Wix.com platform. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

We also store your data with our email and CRM providers, HubSpot and MailChimp. They store your data on secure servers behind a firewall.

Therefore our company may be allowed to retain Personal Data for a longer period whenever the User has given consent to such processing, as long as such consent is not withdrawn. Once the retention period expires, Personal Data shall be deleted. Therefore, the right to access, the right to erasure, the right to rectification and the right to data portability cannot be enforced after expiration of the retention period.

Personal Data shall be processed and stored for as long as required by the purpose they have been collected for.

Marketing

You have the right at any time to stop investRe from contacting you for marketing purposes. If you no longer wish to be contacted for marketing purposes or to unsubscribe from our newsletter, please contact us at info@investre.eu.

What are your data protection rights

We would like to make sure you are fully aware of all your data protection rights. Every user is entitled to the following:

- the right to be informed - you have the right to informed about the collection and use of your personal data.
- the right of access – you have the right to request our company for copies of your personal data.
- the right to rectification - you have the right to request that our company correct any information you believe is inaccurate. You also have the right to request our company to complete information you believe is incomplete.
- the right to erasure - you have the right to request that our company erase your personal data, under certain conditions.
- the right to restrict processing - you have the right to request that our company restricts the processing of your personal data, under certain conditions.

- the right to data portability – you have the right to request that our company transfer the data that we have collected to another organization, or directly to you, under certain conditions.
- the right to object and also rights around automated decision making and profiling - you have the right to object to our company’s processing of your personal data, under certain conditions.
